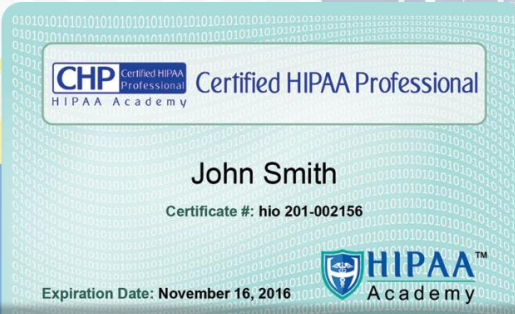
The Health Insurance Portability and Accountability Act (HIPAA) is about insurance portability, fraud, and administrative simplification.

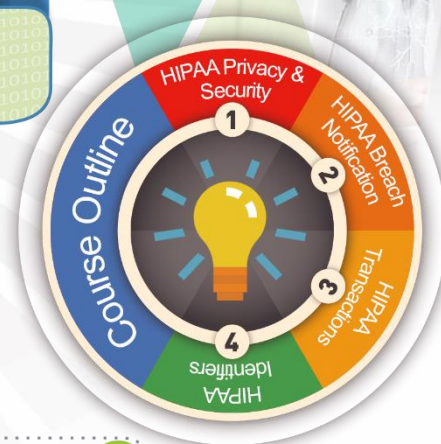
